Contributions up to \$200 for individuals and \$400 for married couples may earn a dollar-for-dollar tax credit on Arizona Income Tax, which means your total tax bill can be reduced by this amount!

In addition, your gift to WellCare may qualify as a charitable deduction on your federal return if you itemize.
